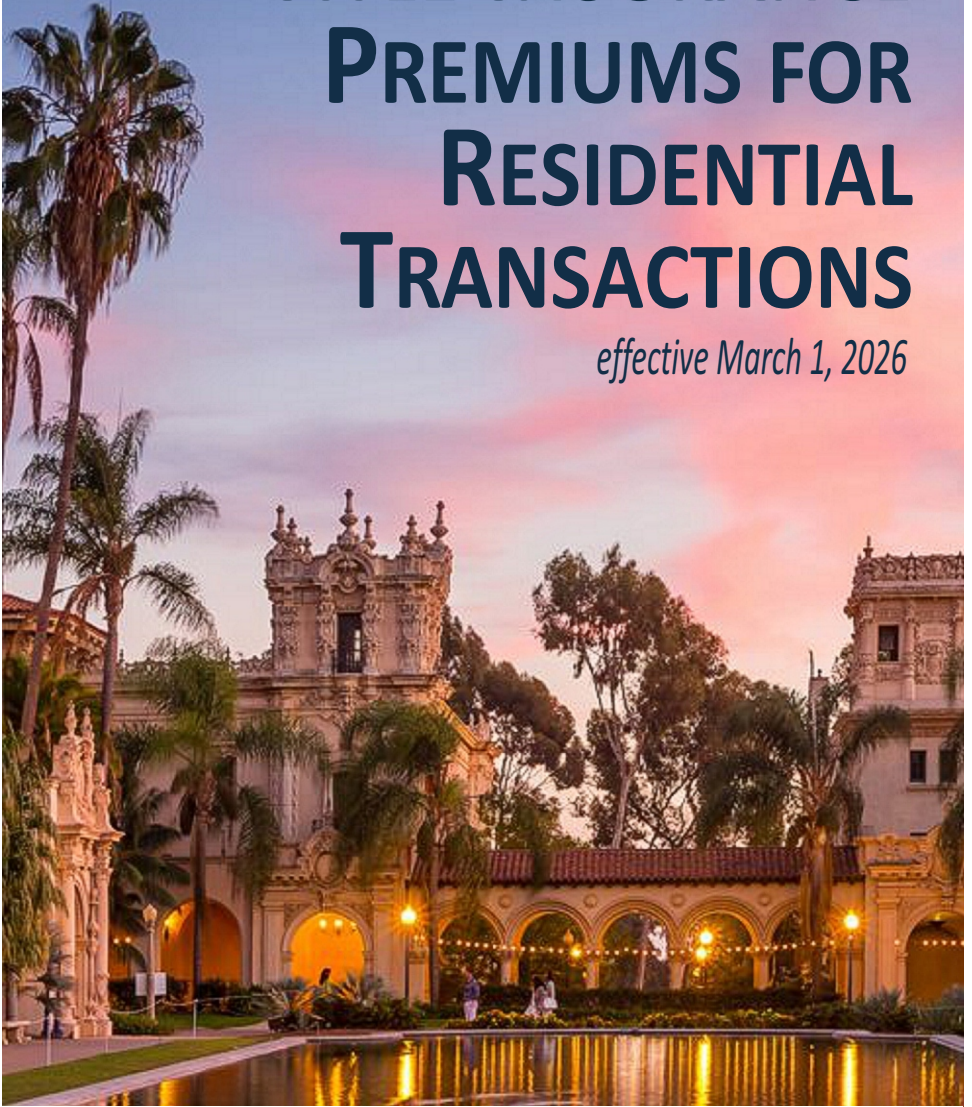

The EAGLE Owner's Policy is an expanded coverage policy applicable to one-to-four family residences.

**COLUMN 4 -  
Non-EAGLE Loan Policy without WRE\* issued concurrent  
with Owner's Policy**

The premium for a Non-EAGLE Loan Policy without WRE\* issued simultaneously with an owner's policy which insures for the full value of land and improvements.

**COLUMN 5 -  
Non-EAGLE Loan Policy without WRE\* issued as a  
stand-alone policy**

The premium for a Non-EAGLE Loan Policy without WRE\* issued as a stand-alone policy not issued simultaneously with an owner's policy and where the proceeds of the loan do not fund the construction of improvements.
